2. The Solicitors' Indemnity Rules 1987 as amended from time to time shall be further amended with effect from 1 October 2023 and shall continue in force thereafter in the form annexed hereto in which form they may be known as the SRA Indemnity Fund Rules.
3. The Solicitors' Indemnity (Incorporated Practice) Rules 1991 as amended from time to time shall continue in force only in respect of the [indemnity periods](https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period-2012) [\[https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period-2012\]](https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period-2012) commencing on 1 September 1991 and 1 September 1992.

The indemnity available in respect of the [indemnity periods](https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period-2012) [\[https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-](https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period-2012)



[period-2012](#) commencing prior to 1 October 2023 shall remain unaltered.

7. In these Rules the terms in italics will have the meaning set out in Rule 3.1 of the SRA Indemnity Fund Rules annexed hereto.
