Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

- 1. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#SRA]</u> shall establish and maintain a fund for making grants in respect of claims made in accordance with these rules.
- <u>Solicitors [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u>, <u>RELs</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#REL], <u>RFLs [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#REL]</u>, [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#RFL], recognised bodies [https://consultations.sra.org.uk/solicitors/standards-

- The <u>Fund [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> is a discretionary fund of last resort and no <u>person [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> has a right to a grant enforceable at law.
- 3. The primary objects of the <u>Fund</u> [<u>https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund</u>] are:
 - 1. to replace money which a <u>defaulting_practitioner</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] or a <u>defaulting</u> practitioner's [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] employee or <u>manager</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#manager] has misappropriated or otherwise failed to account for; and
 - 2. to relieve losses arising from the civil liability on the part of a <u>defaulting_practitioner</u> [<u>https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner</u>] or a <u>defaulting</u> <u>practitioner's [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner</u>] employee or <u>manager</u> [<u>https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner</u>] employee or <u>manager</u> [<u>https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#manager</u>] who in accordance with the SRA

3. For any grant to be made out of the <u>Fund</u>

- 3. For the purposes of rule 3.1(b):
 - an individual whose dealings have been in a personal capacity with the <u>defaulting practitioner</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and
 - 2. a body corporate, or an individual whose dealings have been in a business capacity with the <u>defaulting practitioner</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account must provide evidence to satisfy the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#SRA] that it, he or she (the body or individual) has suffered or is likely to suffer hardship.
- 3. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#SRA]</u> may make a grant as an interim measure.
- 4. 4. A person [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#person] is eligible under this rule to apply for a grant out of the Fund [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#Fund] where the person

- 1. is an individual; or
- 2. at the time the application is made, is a sole trader, partnership [https://consultations.sra.org.uk/solicitors/standards-<u>regulations/glossary/#partnership]</u>, body corporate, unincorporated association or mutual association with an annual turnover [https://consultations.sra.org.uk/solicitors/standards-<u>regulations/glossary/#turnover</u>] of less than £2 million,
- and does not fall within rule 4.2, 4.3(a) or 4.4(a).
- 5. A person [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#person] is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) if at the time the application is made the person

- 1. at the time the application is made falls within one or more of the following categories:
 - a <u>charity [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#charity]</u> with annual income net of tax in the most recent financial year of less than £2 million; or

 - a <u>trustee [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#trustee]</u> of a trust with an asset value of £2 million or more; and
 - 2. has satisfied the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> that its beneficiaries have suffered, or are likely to suffer, hardship if a grant is not made.

- 5. The SRA may only make a grant in respect of acts or omissions of a <u>defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u>, or of a <u>defaulting practitioner's [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> employee, <u>owner</u> [<u>https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> or <u>manager [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u> as appropriate, which fall within rule 3.
- 6. A <u>defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner]</u> means:
 - 1. a <u>solicitor [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> or an <u>REL</u>

- 2. a <u>solicitor [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#solicitor]</u> or an <u>REL</u> [<u>https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#REL]</u> who at the date of the relevant act or omission:
 - 1. was self-employed and practising in their own name, and not through a trading name or service company;
 - 2. did not employ anyone in connection with the services they provided; and
 - 3. was engaged directly by their clients with their fees payable directly to them;
- an <u>RFL [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#RFL]</u> who is a manager or owner of an authorised body;
- 4. a <u>recognised body [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body]</u>; Or
- 5. a <u>licensed body [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body]</u>,

and the expressions "defaulting solicitor", "defaulting REL", "defaulting recognised body", "defaulting RFL" and "defaulting licensed body" shall be construed accordingly.

- 7. A grant may be made where, at the date of the relevant act or omission:
 - a <u>defaulting solicitor [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> had no practising certificate in force;
 - the registration of a <u>defaulting REL</u> [<u>https://consultations.sra.org.uk/solicitors/standards-</u> regulations/glossary/#defaulting-practitioner]_or <u>defaulting RFL</u> [<u>https://consultations.sra.org.uk/solicitors/standards-</u> regulations/glossary/#defaulting-practitioner]_had expired or been revoked;
 - the authorisation of a <u>defaulting recognised body</u> [<u>https://consultations.sra.org.uk/solicitors/standards-</u> regulations/glossary/#defaulting-practitioner]_or <u>defaulting licensed</u> <u>body [https://consultations.sra.org.uk/solicitors/standards-</u> regulations/glossary/#defaulting-practitioner]_had been suspended or revoked;

provided that the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#SRA]</u> is satisfied that the <u>applicant</u> [<u>https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> was unaware of the absence of a valid practising certificate or the relevant expiry, suspension or revocation (as the case may be).

The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-</u> regulations/glossary/#SRA1 may make a grant to a <u>defaulting practitioner</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] who or which has suffered or is likely to suffer loss by reason of their liability to any client in direct consequence of an act or omission of:
 - in the case of a <u>defaulting solicitor</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner], <u>defaulting REL</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] or <u>defaulting RFL</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner], any of their employees or any fellow <u>manager</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#manager];

The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to alleviate a deficiency in a <u>statutory trust [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust]</u> held by the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA].
- 8. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#SRA]</u> may make a grant to a <u>person</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person] where the money would have been due to that <u>person</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person] but for their claim having been extinguished under rule 8.2 of the SRA Statutory Trust Rules.

- 9. Where the application for the principal grant is in respect of a failure to redeem a mortgage, the <u>SRA</u> [<u>https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA</u>] may also make a grant in respect of the additional interest accrued to the mortgage account as a result of the <u>defaulting practitioner's</u>

 - 4. are for interest payable to the <u>applicant</u> [https://consultations.sra.org.uk/solicitors/standards-

- 5. are suffered by the Legal Aid Agency as a result of making regular payments under the Agency's contracting schemes for civil or criminal work;

Rule 16: Application and time limit

An <u>applicant [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> must make an application for a grant in the <u>prescribed [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed]</u> form, and within 12 months of the date they first became aware, or should reasonably have become aware, of the loss.
- 17. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-</u> regulations/glossary/#SRA] may extend the 12 month period in rule 16.1 if satisfied that there are circumstances which justify the extension of the time limit.
- 18. The applicant [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#applicant] must provide information, documents and evidence requested by the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA], which may include verification of matters by statement of truth or affidavit. Failure to provide such documentation or to co-operate with the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-</u> regulations/glossary/#SRA] will be taken into account when determining the merits of the application.

18. - 20. The fact that an application has been rejected does not prevent a further application being submitted provided that material new relevant evidence or information is produced in support of the new application.

Where an <u>applicant [https://consultations.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#applicant]</u> intends to or has already instituted proceedings for recovery of their loss and wishes to apply for a grant in respect of the costs of the proceedings, the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] will only consider such costs where:
 - 1. they can be shown to be proportionate to the loss and the amount likely to be recovered; or
 - the proceedings were necessary for the making of an application to the <u>Fund</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#Fund].
- 21. Where a grant is made, the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may consider an application for a further grant in respect of the reasonable costs properly incurred by the <u>applicant</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] with either their solicitor or other professional adviser, provided that such costs were incurred wholly, necessarily and exclusively in connection with the preparation, submission and proof of the application.
