The review focuses on how to reduce the risk that something goes wrong at a regulated law firm, while finding the right balance between protections and potential impact on the cost of legal services. Included in this review is consideration of compensation fund arrangements.

Sanctions guidance - all firms must comply

The sanctions regime is run by the Government and supports measures to protect the UK's interests. All firms are captured by the regime, it is not just for those firms that are in scope of the money-laundering regulations. We have produced guidance on complying with sanctions as a large number of you will not be familiar with some of the requirements.

Politically exposed persons - changes to the regulations

The money laundering regulations have been changed to alter the status of politically exposed persons (PEPs) depending on whether or not they are from the UK or overseas. While you must still carry out the same amount of due diligence, such PEPs are now deemed lower risk.
