This outcome was reached by SRA decision.

Reasons/basis

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which reaches its own decision after considering all the evidence, including any evidence put forward by the Respondent. The Tribunal had certified that there was a case to answer.

The matter was heard on 16 and 17 January 2023.

Mr Aziz was made subject to conditions - imposed indefinitely - as follows:

Mr Aziz may not:

1. Practice as a sole manager, practitioner, sole owner, or freelance solicitor.

2. Be partner or member of an LLP, legal disciplinary practice or ABS, or other authorised / recognised body.
3. Be a HOLP / HOFA.
4. Hold client money.
5. Be a signatory on any client money.
