This is a serious matter and we understand your concerns. Given there are ongoing investigations we are limited in how much we can say on the case. However, in this edition we reflect on some of the key questions it raises in terms of the compensation fund, client protection and how we reduce the risk of similar failures in the future. These questions don't have easy answers and resolving them will require careful thought and engagement with the sector. We will be engaging with you – and providing further updates in SRA Update – as we take this work forward.

Also this month, you can read our annual report on anti-money laundering work, which highlights examples of both good and bad practice in this area, as well as new resources we have published to help solicitors comply. You can also find out about our review of the transparency rules, which saw firms acknowledging the benefits they can bring in attracting new clients. Your firm might rely on the Legal Services General Licence as part of its approach to sanctions compliance. The Office of Financial Sanctions Implementation has announced that the licence has been renewed for another six months.

Changes to the fixed recoverable costs regime came into effect at the start of the month. You might need to review the costs information you give to clients, including how they might need to cover any shortfall, or circumstances where they might be responsible for the other side's costs.

If you hold frozen assets under the sanctions regime, you must submit a report to OFSI by Friday 10 November 2023. Your report must include details of all funds or economic resources frozen in the UK as well as those overseas, where these funds or economic resources are subject to UK financial sanctions legislation.
