Rule 1: Maintenance of and contributions to the Fund

- 1. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> shall establish and maintain a fund for making grants in respect of applications made in accordance with these rules.

- 4. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may at any time:
 - 1. borrow for the purposes of the <u>Fund</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund];
 - 2. charge investments which form part of the Fund [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] as security for borrowing by the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] for the purposes of the Fund [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund].

Rule 2: Residual discretion and fund of last resort

- 2. The Fund [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] is a discretionary fund of last resort and no person [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person] has a right to a grant enforceable at law. The SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] retains a discretion to refuse to consider an application or to make a grant notwithstanding that the conditions in these rules for making a grant are satisfied.
- 3. The circumstances in which the residual discretion in rule 2.1 may be exercised include, but are not limited to, circumstances in which the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] considers that the loss suffered is not material in all the circumstances or has been appropriately compensated through another means.
- 4. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may refuse or reduce a grant where the loss or part of the loss is, or was, capable of being made good or appropriately compensated by some other means, including another compensation scheme.

Rule 3: Grants which may be made from the Fund

- 3. A <u>person [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> may apply for a grant out of the <u>Fund [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u>, if the loss referred to in rule 3.3 relates to services provided:
 - 1. by the <u>defaulting_practitioner</u>
 [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] for them; or
 - 2. to, or as, a <u>trustee [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#trustee]</u> where they are a beneficiary of the estate or trust.
- 3. A <u>person [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> who is not a client of the <u>defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> may apply for a grant out of the <u>Fund [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> if they:
 - 1. were a party on the other side of a legal matter on which the <u>defaulting practitioner</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]_was acting; and
 - 2. have suffered, or are likely to suffer, financial loss in accordance with rule 3.3 arising as a result of the <u>defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> failing to apply funds for the purpose intended where they should have been used (whether on completion of certain conditions or otherwise) to complete a transaction for their benefit, or to make a settlement or other payment to them.
- 3. For any grant to be made out of the Fund

 (save in respect of a grant made under rule 3.4) has suffered, or is

 - 1. the dishonesty of a <u>defaulting practitioner</u>

<u>regulations/glossary/#defaulting-practitioner]</u> or a <u>defaulting practitioner's</u> [https://consultations.sra.org.uk/solicitors/standards-

regulations/glossary/#defaulting-practitioner] employee, manager

- 3. the loss is not covered by the <u>SIF</u>

- 5. No grant will be made under rule 3.4 where due to the insolvency or cessation of the insurer [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] the defaulting_practitioner's policy [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] of qualifying_insurance [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] has been disclaimed or otherwise ceases.
- 6. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#sra] may make a grant as an interim measure in relation to part of an application before the application has been fully assessed.</u>

Rule 4: Eligibility for a grant

- 4. A <u>person [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> is eligible to apply for a grant out of the <u>Fund [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> if, at the time the application is made, they are:
 - 1. an individual;
 - 2. a sole trader; <u>partnership</u>
 [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#partnership], body corporate, unincorporated
 association or mutual association with an annual <u>turnover</u>
 [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#turnover] or <u>assets</u>
 [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#asset] of less than £2 million;
 - 3. a charity [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#charity] with annual income net of tax in the most recent financial year of less than £2 million; or
 - 4. a <u>trustee [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#trustee]</u> of a trust with an asset value of less than £2 million.
- 5. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may take into account such evidence as it sees fit when determining eligibility under rule 4.1 and may make a broad estimate of any relevant amount.



Rule 5: Defaulting practitioners

- 5. A <u>defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> means:
 - a <u>solicitor [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor1</u>, an <u>REL [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#REL]</u> or an <u>RSL [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#RSL1</u> who at the date of the relevant act or omission was:
 - 1. practising in an <u>authorised body</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]; Or
 - 2. practising in a <u>non-commercial body</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body];
 - 2. a <u>solicitor [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> or an <u>REL</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission:
 - 1. was self-employed and practising in their own name, and not through a trading name or service company;
 - 2. did not employ anyone in connection with the services they provided; and
 - 3. was engaged directly by their clients with their fees payable directly to them;
 - 3. an RFL [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#RFL] who is a manager or owner of an authorised body;
 - 4. a <u>recognised body [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body]</u>; **Or**
 - 5. a <u>licensed body [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body]</u>,
 - and the expressions "defaulting solicitor", "defaulting REL", "defaulting RSL", "defaulting recognised body", "defaulting RFL" and "defaulting licensed body" shall be construed accordingly.
- 6. A grant may be made where, at the date of the relevant act or omission:
 - 1. a <u>defaulting solicitor [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> had no practising certificate in force;
 - 2. the registration of a <u>defaulting REL</u>
 [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner], <u>defaulting RFL</u>
 [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] or <u>defaulting RSL</u>
 [https://consultations.sra.org.uk/solicitors/standards-

- <u>regulations/glossary/#defaulting-practitioner]</u> had expired or been revoked;
- 3. the authorisation of a <u>defaulting recognised body</u>
 [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] or <u>defaulting licensed</u>
 body [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] had been suspended or revoked;

provided that the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> is satisfied that the <u>applicant [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> was unaware of the absence of a valid practising certificate or the relevant expiry, suspension or revocation (as the case may be).

Rule 6: Grants to defaulting practitioners

- 6. The SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a grant to a defaulting-practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] who or which has suffered or is likely to suffer loss by reason of their liability to any client in direct consequence of an act or omission of:
 - in the case of a <u>defaulting solicitor</u>
 [https://consultations.sra.org.uk/solicitors/standards regulations/glossary/#defaulting-practitioner], <u>defaulting REL</u>
 [https://consultations.sra.org.uk/solicitors/standards regulations/glossary/#defaulting-practitioner], <u>defaulting RFL</u>
 [https://consultations.sra.org.uk/solicitors/standards regulations/glossary/#defaulting-practitioner] or <u>defaulting RSL</u>
 [https://consultations.sra.org.uk/solicitors/standards regulations/glossary/#defaulting-practitioner] any of their employees or
 any fellow <u>manager [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u>;
 - in the case of a <u>defaulting recognised body</u>

 - 3. in the case of a <u>defaulting licensed body</u>

in circumstances where, but for the liability of the <u>defaulting</u> <u>practitioner</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], a grant might have been made from the <u>Fund</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]

- 7. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant under this rule by way of a loan upon such terms as the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] specifies.
- 8. In the case of a <u>defaulting recognised body</u> [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] or a defaulting licensed body [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner], the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make such grant payable to one or more of the managers [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#manager] Or OWNers [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#owner] of the defaulting recognised body [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] or defaulting licensed body [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner]. If a loan is made to more than one person [https://consultations.sra.org.uk/solicitors/standardsregulations/glossary/#person], they shall be jointly and severally liable for the repayment of the loan.

Rule 7: Grants in respect of statutory trusts

- 7. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to alleviate a deficiency in a <u>statutory trust [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust]</u> held by the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA].
- 8. The SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a grant to a person [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person] where the money would have been due to that person [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#person] but for their claim having been extinguished under rule 9.2 of the SRA Intervention Powers (Statutory Trust) Rules 2011 or rule 8.2 of the SRA Statutory Trust Rules.

- 8. In respect of any grants made under rules 3, 6 or 7 the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a supplementary grant by way of a sum in lieu of lost interest on the loss underlying the principal grant. Such interest will be calculated by the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] in accordance with prescribed [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed] rates.</u>
- 9. Where the application for the principal grant is in respect of a failure to redeem a mortgage, the <u>SRA</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may also make a grant in respect of the additional interest accrued to the mortgage account as a result of the <u>defaulting practitioner's</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] failure to redeem.

Rule 9: Maximum grant

- 9. Unless the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> is satisfied that there are exceptional circumstances in the public interest that justify a higher sum, the maximum grant that may be made is £2 million.
- 10. For the purposes of this rule, a single claim is an application, or applications, from an <u>applicant</u>
 [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] for the loss incurred by them arising from a single event or set of connected underlying circumstances.

Rule 10: Capping payments of multiple applications

- 10. Where multiple applications are made to the <u>Fund</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]:
 - 1. that relate to the same or connected underlying circumstances; and
 - 2. the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> is satisfied that the total amount of the grants made from the <u>Fund</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] in respect of such applications is likely to exceed £5 million,

- the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may impose a limit on the total amount to be paid in respect of those applications of £5 million.
- 11. Where the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> imposes a limit under rule 10.1, the amount paid may be apportioned between the <u>applicants</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] to whom the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> is satisfied a grant is payable, in such of the following ways as the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> considers appropriate in the circumstances:
 - 1. the amount to be apportioned equally between all those who have made an application within such reasonable time period for the purpose as shall be published by the SRA
 <a href="https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]; or
 - 2. such percentage of loss or amount to be paid, as the <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> considers appropriate in all the circumstances.

- 11. A grant may be refused or reduced to take account of:
 - 1. dishonest, improper or unreasonable conduct by the <u>applicant</u> [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] or anyone acting on their behalf:
 - 1. in the circumstances that gave rise to the application;
 - 2. in relation to the application itself; or
 - 2. failure to pursue the application promptly, co-operatively and in good faith.
- 12. A grant may be refused or reduced to take account of any act or omission by the applicant [applicant or anyone acting on their behalf that has contributed to or has failed to mitigate the loss.

Rule 15: Application and time limit

- 15. An <u>applicant [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> must make an application for a grant in the <u>prescribed [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed]</u> form, and within 12 months of the date they first became aware, or should reasonably have become aware, of the loss.
- 16. The <u>SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may extend the 12 month period in rule 15.1

if satisfied that there are circumstances which justify the extension of the time limit.

17. The applicant [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] must provide information, documents and evidence requested by the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA], which may include verification of matters by statement of truth or affidavit. Failure to provide such documentation or to co-operate with the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] will be taken into account when determining the merits of the application.

The SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may not make a grant unless it has given not less than 8 days' notice to the defaulting-practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] informing them of the nature and value of the application, unless it appears to the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it would not be reasonably practicable to give such notice, or the grant should be made urgently.
- 17. Where the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] has made a grant urgently in accordance with rule 16.1, the SRA [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] shall as soon as, and so long as, it is practicable to do so, give notice to the defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] in the terms set out in rule 16.1 and may (insofar as any failure to give notice before the making of the grant has prejudiced the defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]) waive in whole or in part the Fund's [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] right of recovery under rule 18 against the defaulting practitioner [https://consultations.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner].

- 19. The fact that an application has been rejected does not prevent a further application being submitted provided that material new relevant evidence or information is produced in support of the new application.
