3. Mr Simpkins does not hold or receive client money, or act as a signatory to any client or office account or have the power to authorise transfers from any client or office account.
4. Mr Simpkins does not provide legal services as a freelance solicitor offering reserved or unreserved services on his own account under Regulation 10.2(a) or (b) of the SRA Authorisation of Individuals Regulations.

This outcome was reached by SRA decision.

Reasons/basis

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which will reach its own decision after considering all the evidence, including any evidence put forward by the Solicitor. The Tribunal has certified that there is a case to answer in respect of allegations which are or include that, whilst in practice as a Solicitor at Simpkins & Co Solicitors, he:

1. Caused or allowed the firm to have a minimum client account shortage in relation to client A.
2. Caused or allowed the firm to have a minimum client account shortage in relation to client B.
3. As the firm's sole manager, COLP and COFA, failed to have sufficient control and adequate supervision or oversight of the firm.
4. Provided information to the Forensic Investigation Officer of the SRA regarding the financial status of the firm that he knew/ought to have



known was inaccurate and/or misleading.

The allegations are subject to a Hearing before the Solicitors Disciplinary Tribunal and are as yet unproven.
